GENERAL TERMS AND CONDITIONS

MEMBERSHIP QUALIFICATIONS

MEMBERSHIP SALES ALLOCATION / WAITING LIST / ROSTER NUMBER

Memberships at Pin High will be limited and up to the sole discretion of Pin High on how many memberships are available.

RULES AND REGULATIONS

All Members agree to abide by the rules and regulations while in the facility. These rules and regulations may change from time to time at the discretion of Pin High. Failure to abide by the club rules and regulations may result in termination of membership.

DAMAGES

Members accept responsibility for all property damages except due to ordinary wear and usage caused by themselves or their guests. Pin High shall not be liable to Members and their guests for property damaged, lost, or stolen in or about the facility and the Member hereby releases Pin High from any such loss.

REFUND/POLICY CHANGES

Pin High reserves the right to change fees, services, and operational procedures without prior notice to the Member.

SUSPENSION AND TERMINATION

Pin High may terminate a Member by notification in writing, at the last address shown on the records for that Membership. A terminated Member will remain liable for all indebtedness incurred. At the sole discretion of facility management, the Member of any membership who is in arrears in his or her account to the facility may be suspended or terminated.

SEVERABILITY

In the event any part or parts of this agreement are determined invalid or unenforceable, such part or parts shall be severed and their remainder shall be in effect.

GENERAL

This agreement may not be assigned or otherwise transferred, in whole or in part, by the Member. This agreement shall be governed by the laws of Iowa, exclusive of its choice of law provisions. In the event that Pin High commences any action to recover amounts due from the member, it shall be entitled to recover its attorneys' fees and costs. No provision of this agreement may be waived, unless such waiver is in writing. No waiver in any one instance shall be effective in any other instance. The fact that one party or the other party drafted this agreement shall not be considered in the interpretation of this agreement. The obligations of a Member to Pin High shall survive any termination or cancellation of this agreement. Any liability of Pin High to the member shall be limited to return of the initial annual fee.

AGREEMENT

Member is subject to approval by Pin High and shall be effective only when Pin High approves this agreement.
